

# **Big Bad Jackpot Frenzy!**

## **Madill Gaming Center**

### **Official Rules**

1. Madill Gaming Center is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Madill Gaming Center is giving away up to \$3650 in Mega Frenzy Tickets beginning in October 2018 and ending in September 2019 throughout the “Big Bad Jackpot Frenzy!” promotion.
2. Patrons must be 18 years of age or older with a valid photo ID to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Madill Gaming Center; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies; regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Starting October 1<sup>st</sup>, 2018 through September 30th, 2019 the first ten (10) Special Wins or Jackpots of \$1,200 or more each day will also receive \$1 in Mega Frenzy Bingo tickets.
  - a.) Patrons must have a valid photo ID to receive tickets.
  - b.) No Limit on number of tickets awarded to each Patron. Patrons will receive \$1 in Mega Frenzy Bingo tickets for every Special win or Jackpot while supplies last.
  - c.) In the event a Patron refuses a prize, that prize will be awarded to another winner.
4. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
5. Acceptance of prize constitutes winner’s permission for the Chickasaw Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
6. Any situation or dispute not covered by these Official Rules will be resolved by the Chickasaw Nation in a manner deemed by the Chickasaw Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, the Chickasaw Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, participants may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
7. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
8. Participation in this promotion and/or tournament further constitutes the affirmative consent of each patron to the exclusive jurisdiction of the Chickasaw Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
