Official Rules

1. Madill Gaming Center is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Madill Gaming Center is giving away over \$3,000 in cash and Prizes during “The Royal Package” Promotion.
2. Patrons must be 18 years of age or older with a valid photo ID to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Madill Gaming Center; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies; regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Beginning January 11th, 2019 until February 13th, 2019 patrons may earn (1) hopper entry for every \$50 cashed out at the Cash Cage.
 - a.) Cashier must be present to issue a valid entry, as well as place each entry into hopper.
 - b.) Hopper will be emptied after each drawing night, and all entries voided for the next drawing night.
4. On January 16th, January 30th, and February 13th of 2019, hopper drawings will take place from 6:30 p.m. to 9:30 p.m. Patrons will be drawn and have the opportunity to choose a card from a container to determine their cash prize. Cash prizes will be given as four (4) \$25, two (2) \$50, two (2) \$150, one (1) \$200. At 9:30 p.m. each night the Grand Prize winner will receive an Artesian Hotel and Casino Package. (value of \$329)
 - a.) Package includes: One (1) night stay at ARTH in Sulphur, Oklahoma (\$99), One (1) Couples package to Sole’renity Spa (\$160), One (1) Gift Certificate to Springs Restaurant (\$50), and Free Play at ARTC (\$20).
 - b.) Winner(s) will have One (1) minute to respond. If winner does not respond within One (1) minute, a new winner will be drawn.
 - c.) Limit of One (1) preliminary cash prize per Patron per promotion night.
 - d.) Limit of One (1) Grand Prize per Patron for the duration of this promotion.
 - e.) Grand Prize Winner(s) will be responsible for booking all reservations included in the Artesian Hotel and Spa Package in advance i.e. before the day of redemption.
 - f.) Madill Gaming Center’s manual drawing system will be the sole determinant of each winner.
5. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
6. Acceptance of prize constitutes winner’s permission for the Chickasaw Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.

7. Any situation or dispute not covered by these Official Rules will be resolved by the Chickasaw Nation in a manner deemed by the Chickasaw Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, the Chickasaw Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, participants may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
8. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
9. Participation in this promotion and/or tournament further constitutes the affirmative consent of each patron to the exclusive jurisdiction of the Chickasaw Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
