

Scorching Summer Staycation

Madill Gaming Center

Official Rules

1. Madill Gaming Center is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Madill Gaming Center is giving away \$12,000 in cash throughout the “Scorching Summer Staycation” promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D. The following individuals or entities are not eligible to participate or win during this promotional activity: Employees of Madill Gaming Center; Employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Beginning April 1st, 2019 through May 29th, 2019 Patrons will be able to earn entries for the drawings in the following ways:
 - A.) Patrons will receive one (1) entry ticket for every electronic gaming machine cash-out ticket of \$100 (or more). Limit of one (1) entry ticket per cash-out ticket.
 - B.) Patrons who receive jackpots of \$2,000.00 or more on Fridays and Saturdays will receive Two (2) entries into the hopper, until 5 p.m. on April 27th.
 - C.) Double entries will be awarded every Tuesday and Sunday throughout the promotion. Patron(s) will receive two (2) entry tickets for electronic gaming machine cash-out ticket of \$100 (or more). Limit of (2) entry tickets per cash out ticket.
 - D.) Any patron that purchases \$20 or more in Mega Frenzy Bingo Tickets will receive two (2) entries into the drawing.
 - E.) Entry tickets must be filled out legibly and completely, with a pen, and turned into the designated hopper on same day received or they will be deemed invalid.
4. On the Wednesdays of April 10th, 17th, 24th and May 1st, 8th, 15th, 22nd, and 29th Madill Gaming Center will be giving away \$1,500 per night. Drawings will begin at 6:30 pm and run every 15 minutes until the Grand Prize drawing at 9:30 pm. Cash will be given as: four (4) \$50, three (3) \$100, two (2) \$150, two (2) \$200, and Grand Prize of one (1) \$300. Preliminary cash winner(s) will have the opportunity to randomly pick their prize amount from a board.
 - A.) Patron(s) must be present to win. Winner(s) will be announced and have one (1) minute to respond. However, if the announced winner does not respond within the allotted time a new winner will be drawn.
 - B.) Limit of one (1) preliminary prize per Patron per night of this promotion. All patrons eligible for Grand Prize each night.
 - C.) Madill Gaming Center’s manual drawing system will be the sole determinant of each winner.
 - D.) Entries will not carry over from one week to the next. All entries will be dropped following the final drawing each week.

E.) Patrons in possession of a valid, applicable direct offer distributed in association with this promotion are eligible to redeem these offers for additional entries.

5. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable provided by the Chickasaw Nation.
6. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
7. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
8. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
9. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion
