

Sweet September Hot Seats

Madill Gaming Center

Official Rules

1. Madill Gaming Center is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Madill Gaming Center is giving away \$10,000 in cash throughout the “Sweet September Hot Seat” promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D. The following individuals or entities are not eligible to participate or win during this promotional activity: Employees of Madill Gaming Center; Employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Every Saturday in September (9/7, 9/14, 9/21, 9/28) random hot seat drawings will be held from 6:00 p.m. to 10:00 p.m. Madill Gaming Center will be giving away \$2,500 per night. Drawings will take place every 30 minutes and the Grand Prize drawing will be held at 10:00 p.m. Cash will be given as; two (2) \$50, three (3) \$100, three (3) \$200, two (2) \$300, one (1) \$400, and one Grand Prize of one (1) \$500. Preliminary cash winner(s) will have the opportunity to randomly pick their prize amount from a Fall themed prop.
 - a. Patrons must be present and actively playing at the time of each drawing to be eligible for random selection.
 - b. Limit of One (1) Preliminary cash prize per Patron per night.
 - c. All Patrons eligible for Grand Prize each night.
 - d. Madill Gaming Center representative will verify a patron is playing the machine at the selected hot seat, if no one present at the machine, a new winner will be drawn.
 - e. Madill Gaming Center’s manual drawing system will be the sole determinant of each winner.
4. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable provided by the Chickasaw Nation.
5. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
6. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
7. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
8. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
