Official Rules

1. Madill Gaming Center is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Madill Gaming Center is giving away \$3,000 in cash during the “Monster Cash” Promotion.
2. Patrons must be 18 years of age or older with a valid photo ID to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Madill Gaming Center; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies; regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. On Wednesdays October 9th and 23rd, Madill Gaming Center will host random hot seat drawings from 6:30 pm to 9:30 pm and we will give away a total of \$1,500 in cash each night. Cash prizes will be given as: four (4) \$50, two (2) \$75, two (2) \$100, three (3) \$150, one (1) \$200, and one (1) \$300 winners. Winners will have the opportunity to randomly choose one (1) Monster from a Halloween themed prop to determine their cash prize amount.
 - a.) Patrons must be present and actively playing an electronic gaming machine at the time of each drawing to be eligible for random selection.
 - b.) Limit of one (1) prize per Patron, per drawing date during this promotion.
 - c.) A Madill Gaming Center representative will verify if a Patron is playing the machine at the selected hot seat. If no one present at the machine, a new winner will be drawn.
 - d.) Madill Gaming Center’s manual drawing system will be the sole determinant of each winner.
4. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
5. Acceptance of prize constitutes winner’s permission for the Chickasaw Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
6. Any situation or dispute not covered by these Official Rules will be resolved by the Chickasaw Nation in a manner deemed by the Chickasaw Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, the Chickasaw Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, participants may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
7. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
8. Participation in this promotion and/or tournament further constitutes the affirmative consent of each patron to the exclusive jurisdiction of the Chickasaw Nation, its

regulatory bodies and courts without limit to time or event, which shall govern this promotion.
