Madill Gaming Center

Official Rules

1. Madill Gaming Center is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Madill Gaming Center is giving away \$8,000 in cash throughout the “Twisted Cash!” promotion.
2. Patrons must be 18 years of age or older with a valid photo ID to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Madill Gaming Center; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies; regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Beginning Saturday, January 25 through March 20, 2020, patrons will be able to earn entries into the drawings in the following ways:
 - A.) Patrons will receive one (1) entry for every \$50 (and above) electronic gaming machine cash-out ticket. Patrons must present their cash-out ticket to the Cashier Cage to receive their entry.
 - B.) Patrons may receive one (1) Free Entry into the hopper for every jackpot or special win over \$1,500 or more.
 - C.) Entries must be filled out legibly, using a pen, and turned into the designated hopper on the date they are issued or they will be deemed invalid.
 - D.) Entries will not carry over across drawing nights. The hopper will be emptied after last drawing of each promotional night.
 - E.) Patrons in possession of a valid, applicable direct offer distributed in association with this promotion are able to redeem these offers for additional entries.
4. On the following Fridays; February 7, February 21, March 6, and March 20, 2020, Madill Gaming Center is giving away \$2,000 each night through earned entry hopper drawings. Drawings will be held from 6:00 pm to 9:30 pm. A total of ten (10) preliminary cash prizes will be away as; five (5) \$100 and five (5) \$200. At approximately 9:30 pm each night, one (1) Grand Prize winner will receive \$500 in cash.
 - a.) Patrons must be present to win. Winner(s) will be announced and given two (2) minutes to respond. However, if the announced winner does not respond within the allotted time a new winner will be drawn.
 - b.) Limit of one (1) preliminary cash prize per Patron, per drawing date during this promotion. Limit of one (1) Grand Prize per Patron for the duration of this promotion.
 - c.) Winners will have the opportunity to randomly select their preliminary cash prize from a Weather themed prop.
 - d.) Madill Gaming Center’s manual drawing system will be the sole determinant of each winner.

5. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
6. Acceptance of prize constitutes winner's permission for the Chickasaw Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
7. Any situation or dispute not covered by these Official Rules will be resolved by the Chickasaw Nation in a manner deemed by the Chickasaw Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, the Chickasaw Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, participants may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
8. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
9. Participation in this promotion and/or tournament further constitutes the affirmative consent of each patron to the exclusive jurisdiction of the Chickasaw Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
